The B2G Conclave was inaugurated by eminent personalities from Government and Private sectors. **Dr. C N Ashwath Narayana**, Hon'ble Deputy Chief Minister, Govt. of Karnataka, **Shri Tejasvi Surya**, Hon'ble Member of Parliament, Bengaluru South, **Shri. Kris Gopalakrishnan**, Cofounder, Infosys inaugurated the event. Representatives from Government, corporate, academia and media were present during the inauguration of *TechBharat 2020* Conclave



In his welcome address, **Shri Srikanta Dutta B.S.**, President of LUB-K, spoke of Laghu Udyog Bharati (LUB) as a non-profit all India organization in the service of Micro & Small Enterprises since last 25 years, has its presence in 24 State with a membership base over 25,000 enterprises across the country and around 1000 members in the State of Karnataka. This being

the silver jubilee year of LUB, series of programs are aligned towards the empowerment of entrepreneurs in Micro and Small sectors.

Further, he stated that Laghu Udyog Bharati (LUB) has got a very strong base of women entrepreneurs which focuses on the encouragement and development of women entrepreneurs in the state. They represent in the areas of food processing, handicrafts and textile & garments sectors.

The president of LUB-K spoke of **INDIA MANUFACTURE SHOW** of IMS Foundation, organised under the aegis of Laghu Udyog Bharati - Karnataka is in service of the Manufacturing Sector in India for their wellbeing and overall development. IMS Foundation has so far conducted four editions of biannual International B2B exhibitions called India Manufacturing Show (IMS) at Bangalore International Exhibition Centre in the year 2010, 2012, 2014 and 2017. The 5th edition of IMS will be conducted between 12th -14th October, 2020.

He welcomed all the delegates & dignitaries invited for the inauguration of the first edition of *TechBharat 2020* Conclave.

Having inaugurated the two days conclave of *TechBharat*, The Deputy Chief Minister of Karnataka of Government of Karnataka, **Dr. C. N. Aswath Narayana** informed the gathering that there is a clear roadmap for new startups in the State of Karnataka in 2020 and by 2022, the goal is to support not less than 9000 of the 20,000 startups to be established in the State of Karnataka. On the occasion of the event Tech Bharat organized by LUB-K, he highlighted that more likely Government of Karnataka will support and extend all possible help and cooperation in this regard. The new startup policy designed by the Government of Karnataka is the first of its kind in the country. There are about 57 incubation centers in the State of Karnataka. The Government has made a provision for a sum of INR 70 Crores for new startups in the space of e-mobility, hospitality, Insurance, Transport, Tourism, etc. At the time of establishing Startups, all legal procedures and hurdles, if any, will be addressed through Karnataka Exploration Authority that has been established. Apart from this, all sorts of facilities are provided for new Startups. Most importantly, from the Government, technology based support will be provided for the new startups

While addressing the gathering, in his Guest of Honour Speech, Hon'ble Member of Parliament, **Shri TEJASVI SURYA** informed that the Central Government has been advocating complimentary polices, which are under the process of formation. International Companies are investing more in this area and that the country is in the upfront for attracting the foreign investments.

While thanking Deputy CM & Shri Kris Gopalakrishnan, he assured all cooperation & support for the Startups across the Country. He highlighted the greater role played by Indian engineers abroad, wherein he shared his experience China's visit and appreciated the contribution of Indian engineers in building a Port in China.

Shri Tejasvi Surya, highlighted about the possible exempting on turnover for startups in the upcoming budget. He opinioned that both Government of India & the Governments of the respective States shall be the growth partner for Startups. Bringing Government to people is a shining example of minimum Government and maximum governance.

Government e-Marketplace (GeM portal) CEO, **Shri Talleen Kumar**, IAS, informed that Bengaluru is ideally suited for setting up startups in the country. Precisely, this city of Bengaluru is growing faster and attracted 14 of the 32 popular companies of the world. He upraised about MSME industries and the role of new technology startups in creating a 5 trillion dollar Economy for the country. As young entrepreneurs taking lead-in startups like Zomato, Swiggy, etc., the startup eco-system in food industry alone will employ 25 lakh people by 2022.

Finally, **Shri Talleen Kumar** spoke of how GeM is facilitating startups in reducing their cost of business; GeM as platform for their business in adopting transparent, inclusive about the features of discounting bills other than quick access to data; cluster-edge technology; digital interface. GeM has advantages for both sellers and buyers.

Shri. Krish Gopalakrishnan, while presiding over the inaugural session, outlined the support to startups from both government and private sectors. He sincerely thanked Laghu Udyog Bharati (LUB) – Karnataka for the unique initiative and wished for more and more editions of *TechBharat* in the years to come.
